

Announcement of Mahidol University

On

The Prohibition of Mahidol University Premise Use in Salaya Campus under the Announcement on the Measures to Prevent and Control the Outbreak of the Coronavirus 2019 (COVID-19) (Omicron Variant) in Nakhon Pathom Province

Reference is made to the release of the Announcement on Adjusting the Measures to Prevent and Control the Outbreak of the Coronavirus 2019 (COVID-19) in Nakhon Pathom Province (No. 4/2565) dated the 23rd February 2022.

Following the current surge of the outbreak of the Coronavirus 2019 (COVID-19) (Omicron Variant) which is easily and rapidly transmitted and has resulted in an increasing number of infected cases, Nakhon Pathom Province therefore re-adjusted certain measures to prevent and control the outbreak in the area as stated in the above-mentioned Announcement. Mahidol University would like to inform all faculties/colleges and institutes in Salaya campus to follow the measures aligned with the Announcement from Nakhon Pathom Province as indicated below:

- 1) All faculties/colleges/institutes and Mahidol University International Demonstration School (MUIDS) are not allowed to use the university premises in Salaya Campus. All activities include teaching and learning, examinations, and trainings or those with a large number of participants, except activities relating to healthcare services or campus security and maintenance. As regards academic activities, teaching and learning, examinations, research and trainings, faculties/colleges/institutes are advised to hold those activities online and to follow Mahidol University's Guideline for Undergraduate Teaching and Learning (Academic Year 2564) dated the 23rd June 2021.
- 2) If holding any activity is considered an utmost necessity, all faculties/colleges/institutes are to follow procedures below:

2.1 activities with 20 but not exceeding 100 participants, a formal request is to be

submitted to the Province's Disease Control Committee for permission at Putthamonthon

District Office at least <u>7 days in advance</u> for approval, on a case by case basis.

2.2 activities with more than 100 but not exceeding 500 participants, a formal request is

to be submitted to the Province's Disease Control Committee for permission through

Putthamonthon District Office at least 10 days in advance for approval by the Governor,

on a case by case basis.

2.3 all faculties/colleges/institutes are to conduct screening tests and negative ATK test

results which are taken within 72 hours prior to the participation in the event from all

attendees are required. Measures to prevent the spread of the Coronavirus 2019 (COVID-

19) advised by the Ministry of Public Health are to be strictly observed.

3) All heads of faculties/colleges/institutes and vice presidents responsible for units and

divisions in the Office of the President are to adjust the ratio of personnel working on-site

and work-from-home to approximately 60 (working on-site): 40 (working from home) or

as seen appropriate. Those in healthcare-related services, campus security and

maintenance units are allowed to work on-site as deemed necessary.

This announcement enters into effect from the 24th February until the 9th March 2022.
