5.3 Other reasons deemed appropriate by the Provider for exempting the Receiver

from responsibility

No.6 The Receiver certifies that they meet the qualifications as stated in the Scholarship Regulations and that all documents submitted to the Provider are true and accurate. If the Receiver does not meet the qualifications or provides false documents, the Provider has the right to terminate or revoke the scholarship as appropriate, and the Receiver agrees to repay all scholarship funds received to the Provider.

No.7 The Receiver wrongfully exercises or does not exercise any of his functions to the injury of any person, or dishonestly exercises or omits to exercise any of his functions, or neglects their duties for a continuous period of seven working days without reasonable cause, the Provider has the right to terminate or revoke the scholarship as appropriate, and the Receiver agrees to repay all scholarship funds received to the Provider.

No.8 In case of the Receiver is required to repay the scholarship under this contract, the Receiver agrees to repay the full amount received within 30 (thirty) days from the date of receipt of written notice from the Provider. If the Receiver fails to make payment within the specified period or makes an incomplete payment, the Receiver agrees to pay interest on the overdue amount at the rate of 5% per annum from the due date until payment is made in full.

No.9 The address of the Receiver as stated in this contract shall be considered the Receiver's domicile. Any notice or document sent to this address shall be deemed properly delivered, and the Receiver will be deemed to have received the contents of such notice or document upon its delivery to their domicile, regardless of whether the Receiver or any other person residing at the domicile receives it. However, if the Receiver changes their address and notifies the Provider in writing, the new address provided to the Provider shall be considered the Receiver's domicile from the date the Provider receives such notification.
